The National Law University Odisha (NLUO) is a vibrant addition to India's national law universities. KARTAVYA- CELEBRATING 70TH CONSTITUTIONAL DAY YEAR LONG

To mark the anniversary of the adoption of India's Constitution on November 26, 1949, in 2015 the Government decided to observe 26th November as 'Constitution Day' or 'Samvidhan Diwas'. On this day in 1949, the Indian Constitution was adopted which came into force on January 26, 1950 marking the beginning of a new era in the history of India.

The 'Constitution Day' will be a part of year-long nationwide celebrations starting from 26th November, 2019 during which number of activities with special emphasis on Fundamental Duties have been planned by UGC throughout the year with active participation of HEIs.

FUNDAMENTAL DUTIES

The Swaran Singh Committee appointed by the Government for a review of the Indian Constitution, in its report submitted in 1976 recommended that certain Fundamental Duties and obligations which every citizen owed the nation should be included in the Constitution.

Article 51 'A', contained in Part IV A of the Constitution deals with Fundamental Duties. These enjoin upon a citizen among other things, to abide by the Constitution, to cherish and follow noble ideals, which inspired India's struggle for freedom, to defend the country and render national service when called upon to do so, and to promote harmony and spirit of common brotherhood transcending religious, linguistic and regional or sectional diversities. Fundamental Duties of the citizens have been enumerated as follows:

- a. to abide by the Constitution and respect its ideals and institutions, the National Flag and the National Anthem;
- b. to cherish and follow the noble ideals which inspired our national struggle for freedom;
- c. to uphold and protect the sovereignty, unity and integrity of India;
- d. to defend the country and render national service when called upon to do so;
- e. to promote harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities; to renounce practices derogatory to the dignity of women;
- f. to value and preserve the rich heritage of our composite culture;
- g. to protect and improve the natural environment including forests, lakes, rivers and wild life, and to have compassion for living creatures;
- h. to develop the scientific temper, humanism and the spirit of inquiry and reform;
- i. to safeguard public property and to abjure violence;
- j. to strive towards excellence in all spheres of individual and collective activity so that the nation constantly rises to higher levels of endeavor and achievement;
- k. who is a parent or guardian to provide opportunities for education to his child or, as the case may be, ward between the age of six and fourteen years.

KARTAVYA- VIDEO MAKING COMPETITION ON FUNDAMENTAL DUTIES [ODISHA]

National Law University being the coordinating university for the state of Odisha for the 70th Constitutional Day Yearlong Celebration in order to sensitize, cherish and abide by the noble ideas- the fundamental duties enshrined under the Indian Constitution is organizing a state-level video making competition on fundamental duties.

EXCEPTED OUTCOMES

- Wider dissemination of information and generating greater awareness in regard to the Fundamental Duties amongst students, faculty and educational administrators
- Encouragement towards acting, implementing and invigorating compliance with Fundamental Duties enshrined in article 51A of the Constitution.

ELIGIBILITY

The Competition is open for all Undergraduates and Post Graduate students [hereinafter collectively referred to as “**Participants**”] from any recognized University/Colleges across the state of Odisha.

THE THEMES OF THE SHORT FILM/VIDEO

The Short Film/ Video must adhere to *at least one* of the following Fundamental Duties:

1. Respecting the National Flag and the National Anthem;
2. Promoting harmony and the spirit of common brotherhood amongst all the people of India transcending religious, linguistic and regional or sectional diversities;
3. Renouncing practices derogatory to the dignity of women;
4. Value and Preserve the rich heritage of our composite culture;
5. Protecting and Improving the natural environment including forests, lakes, rivers and wild life;
6. Having compassion for living creatures;
7. Safeguarding public property and to abjure violence;
8. Providing opportunities for education to his child or, as the case may be, ward between the age of six and fourteen years by the parents and guardians.

PRIZES AND AWARDS

Cash Prize

The meritorious participants would be awarded cash prize as follows:

Winner	Rs. 7000/-
Runners-Up	Rs. 4500/-
2 nd Runners-Up	Rs. 2500/-

Certificate of Excellence

Certificate of Excellence would be awarded to the top 3 teams- Winners, Runners Up and the 2nd Runners Up.

Certificate of Merit

Certificate of Merit would be awarded to the teams who bagged the spot of 4th 5th and 6th Spot in the competition.

GENERAL GUIDELINES FOR THE COMPETITION

1. The Video/Short Films must be *strictly* based on the theme(s) as has been specified above. The participants may choose to make a Video/Short Films on the multiple themes as has been mentioned above.
2. The Participants can make a video/short film in any of the following languages:
 - a. Odia
 - b. Hindi
 - c. English
3. The duration of the Video/Short Film should not be less than ***three minutes*** and should not exceed ***ten minutes***.
4. The Video/Short Film should be creative, original and carry a message for the society.
5. It is encouraged, though not mandatory, in cases where the language is in *Odia* or *Hindi*, to provide subtitles.

Registration

The Eligible Participant can register themselves for the competition by **mailing us** at smc@nluo.ac.in along with **scanned copy of their valid Identity Card(s) issued by their respective college/university** [attached in the same mail] on or before 11:59 PM, 28th June, 2020 at smc@nluo.ac.in.

The mail should be in the following format

Submission

The Eligible Participant who have successfully registered themselves are to upload their video/short film in Google Drive of their respective G-Mail Account. Post uploading, the participants have to create a 'link' which is sharable with the organizers. The participants are then required to give access to the organizer's G-mail account [smc@nluo.ac.in] to have access to their video/short film.

The participants can submit their video/short film by mailing the **link of the Google Drive** [*as mentioned above*] **on or before 11:59 PM, 12 July , 2020** at smc@nluo.ac.in.

Note: *A detailed step-by-step submission procedure guide with pictorial assistance will be sent to the participants post their registration, for their kind assistance.*

The subject of the mail should be '**Submission | Name of the Video**'. For eg. 'Submission | The National Flag' in case the name of the short film is The National Flag.

Judging Criteria

Entries will be judged by experts on the basis of its originality, creativity and its overall cinematography. It must be one which imbibes in itself and cherishes the idea and respect for the fundamental duties.

Anti-Plagism Policy

The Short Film/Video must be original and unpublished work of the participant(s). Any video/short film which is found to be copied/plagrised from an existing video/concept shall be disqualified.
