About Centre for Public Health Law

To advance focused research in the specific domains of law, NLUO has come out with dedicated research centres including on public health. CPHL was established in January 2021 by the Hon'ble Vice-Chancellor, NLUO to promote research in the field of public health laws under the stewardship of Prof. (Dr). Yogesh P. Singh and Ms. Nanditta Batra. It aims to inquire into the paradigm of legal entitlements of people under the right to health and strategise the use of law to promote health equity. In advocating measures for improving the health of the people, we emphasise that public health policies must respect human rights and civil liberties.

Apart from research, the Centre provides guidance and consultancy to government and non-government organizations on health policy. We critically scrutinize the compatibility of various public health policies and programs with the fundamental rights regime. The Centre is working collaboratively with two expert public health organizations i.e. International Union against Tuberculosis and Lung Disease ['The Union'] and the Public Health Foundation of India ['PHFI'].

In the past one year, the Centre for Public Health Law has organised various webinars and special public guest lectures on various topical events including from Prof. (Dr.) Bismi Gopalakrishnan, Ms Kavya Salim, Dr. Amar Jesani, Mr Shantanu Mukherjee and Dr Chandrakant Lahriya.

The Centre is spearheaded by Prof. (Dr.) Yogesh Pratap Singh. He is joined by Ms. Nanditta Batra and Ms. Rishika Khare as Faculty Co-Directors in planning, execution and coordinating various activities.

About Public Health Foundation of India

About the 1st NLUO-PHFI Public Health Law National Moot Court Competition

NLUO takes pride in pioneering the development and teaching of 'Public Health Law' as a specialised course in India. We offer a streamlined study of 'Public Health Law' as seminar course, away from the shadow of Constitutional Law, Medicine and Law and Bioethics. While the Covid-19 pandemic has put a spotlight on just the subject there is a need for broader engagement with administrators, academicians, lawyers, law students across the country to critically analyse the role of law in making health a realizable goal and ensuring distributive fairness in allocation of critical health infrastructure. What better way to do it and cudgel the young minds than a moot. So with an aim to expand our reach to law students across the country and make them think and research about various nitty-gritty's of byzantine legal rules and principles that form the bedrock of public health apparatus we are organising this 2nd PHFI-NLUO Public Health Law Moot. The purpose of this moot is to armour budding lawyers with research skills and arguments on the tensions between civil liberties and states powers and duties with respect to tobacco control.

The 1st edition of the moot was stellar success with participation of 68 teams from across the length and breadth of the country. In the North we had teams from upto Kashmir (Central University of Kashmir) to Kerala (NUALS, Kochi and GLC, Trivandrum) in South, Gujarat in the West [GNLU, Gujarat] to Bengal [NUJS] in the East. The teams represented National Law Universities, Central and State Government Law Department's, Private Law Universities, law colleges (both urban and local). They were judged in the preliminary rounds by a panel consisting of sitting civil judges, senior advocates, advocates before 13 different High Courts, law firm partners and associates, in-house counsels, government counsels and independent researchers. The finals were judged by eminent legal luminaries and public health experts including Mr. Anand Grover, Senior Advocate, Supreme Court of India, Dr. Gagandeep Kang, India's leading virologist and Professor, CMC Vellore, Mr. Murali Neelkanthan, Partner, Amicus, Mr. Sameer Sah, Partner, Khaitan & CO and Mr. Warren Bruke, Senior Attorney, United States House of Representatives, Office of Legislative Counsel. The event also graced by Hon'ble Justice Mr Sanjeeb Panigrahi, Judge, Orissa High Court and Dr. K Srinath Reddy, President, Public Health Foundation of India. Government Law College, Mumbai won the competition and will be awarded a cash prize of Rs 21,000. They also won the citation for 'Best Memorial' and will be awarded a separate cash prize of Rs 10000. Runners up, NALSAR Hyderabad will be awarded a cash prize of Rs. 15,000. Anshika Paul of Government Law College, Trivandrum was adjudicated the 'Best Speaker' and will get a prize money of Rs. 10000. Other hon'ble citations were 'FourthBest Memorial' to Himachal Pradesh National Law University, Shimla, 'Third Best Memorial' to Dr. Ram Manohar Lohia National Law University, Patna, 'Third Best Speaker' as Anagha Ramdass from NUALS, Kochi and 'Second Best Speaker' to Nabeel M from School of Law, University of Mysore.

Guideline for Registration

- The team must upload a certificate of nomination for representing their institute issued by their Moot Court Committee or Registrar or Vice-Chancellor or Principal or Director as the case may be.


