Coordinator to work in the project on the study on Social Protection of Women Migrant Workers

in the State of Odisha

About the research study:

The aim of the study is to understand the situation and causes of women migration, to explore the

implications of their migration economic benefits, social security and safety risks, and to identify

issues for policy action to prevent distress migration. The research report shall be contemplated

with literature review, law and policy analysis, case studies and primary data analysis. The study

will collect the qualitative and quantitative information through consultation, household survey,

interview method, focus group discussions by using structured questionnaires. The study will

conduct field survey in twelve migration prone districts of Odisha namely Cuttack, Gajpati,

Ganjam, Kandhamal, Koraput, Malkangiri, Mayurbhanj, Nabarangpur, Puri,Rayagada,

Nabarangapur and Sundargarh . As many as 5000 women migrant workers in selected Gram

Panchayats across the above –mentioned districts will be interviewed through household survey

to gather information of their personal and family socio-economic status, migration particulars,

work and wages, issues and challenges of their migration, impact of covid pandemic on their

migration, and their social protection awareness. The study will also undertake interview and

interactive discussion with key stakeholders at the district level.

Job Responsibilities:

The Research Coordinator shall coordinate the field study and facilitate surveyor training, data

collection process, development of data production tools, data entry. He/she shall undertake the

responsibilities of content development, data tabulation, data analysis, law & policy analysis and

any other as required for development of the research report. He/ she shall make process

documentation and prepare periodic report to the progress of the study. He/she shall be required

to travel to the districts to monitor and mentor the field study and any other responsibilities as required for the deliverable to the assignments.

Qualification and Other criteria

- 1. Post Graduate in Law or in any Social Sciences
- 2. Well conversant in English and Computer applications
- 3. Expertise in SPSS or R package will be given preference
- 4. Commanding communication and writing skill in English
- 5. Applicant shall not have completed 45 years of age on the last date of submission of Application
