- vii. Please indicate whether you will be able to supply the item within time specified after receiving the order.
- viii. Please specify the minimum period for completion of the work if you are not able to supply within the said period. Early delivery will be a factor for consideration in deciding the successful bidder.
- ix. A penalty of 0.5% of the total order value will be imposed per week for late completion of work to a maximum of 10% of the contract value.
