

The committee constituted by the Vice Chancellor, NLUO met on 8 November 2022 in online mode to scrutinize the documents resubmitted by the following candidates and made the following remarks.

Subrata Kumar Mishra	<p>The candidate has submitted experience certificate issued by the competent authority showing requisite experience.</p> <p>This candidate is eligible to be considered for interview.</p>
Pratap Keshari Dash	<p>The candidate claimed 11 years 7 month experience from the National Institute of Rehabilitation, Training and Research & 2 years and 7 months of experience from the IIM Calcutta. He has submitted the last pay certificate as a supporting document for the former and a copy of the appointment order as the supporting document for latter. In both the cases, the candidate failed to submit a proper experience certificate showing the claimed years of experience issued by competent authority.</p> <p>This candidate is not eligible to be considered.</p>
Joydeep Sil	<p>The candidate has submitted experience certificate issued by the competent authority showing requisite experience.</p> <p>This candidate is eligible to be considered for interview.</p>


The committee constituted by the Vice Chancellor, NLUO met on 8 November 2022 in online mode to consider the petitions submitted by the following candidates to reconsider their applications and made the following remarks.

Pranab Kumar Sarkar	<p>‘holding analogous post’ is an essential experience as per the notification. At the time of applying (November 2020), the candidate was holding the post of the Controller of Examinations in Sikkim University and was drawing salary in PB Level 14 (1,44,200-2,18,200).</p> <p>Academic or administrative experience taken individually, the candidate does not meet the minimum eligibility regarding experience (that is total 15 years).</p> <p>On the basis of the candidate’s experience under the category ‘holding analogous post’ as per the Notification, the candidate is eligible to be considered for interview.</p>
Nikhil Kumar Yadav	<p>The candidate does not have requisite academic experience, that is, ‘15 years of experience as Assistant Professor in the AGP of Rs. 7000...’ The petition submitted by the Candidate claims to</p>


	<p>have 7 years 10 months and 13 Days experience as Assistant Professor in Arba Minch University, Ethiopia. However, the application form claims 7 years and 2 months. The documents submitted by the candidate in support of the above-mentioned claim do not clearly establish the total number of years of experience.</p> <p>The candidate has claimed 20 years of experience as Maintenance Engineer in the Indian Air Force. The experience certificate submitted by the candidate in this regard does not show the requisite experience, that is, '15 years of administrative experience, of which 8 years shall be as Deputy Registrar or an equivalent post in the GP of Rs 7600 or above'</p> <p>The candidate is not eligible to be considered.</p>
