After detailed discussion, the Council approved the selection of Dr. Sukanta K. Nanda as Professor of Law, Dr. A. Aruna Sri Lakshmi, Dr. Sheela Rai, as Associate Professors & Er. Dibyajyoti Kumar Panda as Maintenance Engineer(contractual), NLUO submitted by the respective Selection Committees and instructed to proceed with issuance of appointment orders. Further, it has been instructed to prepare a detail duty chart of the Engineer to be appointed on contractual basis for day today maintenance of the University. He will not be associated with the project.

For smooth conduct of UG & PG classes, the Vice-Chancellor is to move ahead for contractual appointment of suitable Asst. Professors for the current academic year and at the same time applications need to be invited from intending candidates through an advertisement for the required teaching positions.

The Selection committee recommended Mr. Biju Mathew as a suitable candidate for P.S to VC, NLUO. **Confirmation of Non-teaching Staffs**


The Council requested the Vice-Chancellor to place the detail report as desired earlier in the next Executive Council meeting for discussion and approval.
