<p>ISO Audit: ISO Audit was conducted for different departments of the University. The Certificate was issued by Bureau of Indian Standards for providing undergraduate programmes, certificate programmes, post graduate and post graduate diploma programmes and doctoral studies related to law. Continuous improvement in teaching learning process: IQAC focusses on strengthening the teaching learning process by taking into account the current market requirements. The courses are updated by the faculty members on regular basis taking into account the multi-disciplinary perspectives. The courses were revised by the faculty members and the same were presented before the experts before the commencement of the session. Promotion of Research and Publication: To promote the research and publication among the faculty members, the National Law University Odisha Publication Incentive Regulations 2022 was made effective from 6 th August 2022. As per Regulations, the faculty member publishing paper in UGC Care journal shall be entitled to get cash incentive for Rs. 10,000/- and for SCOPUS Indexed Journal the incentive is Rs. 15,000/-. Continued Focus of strengthening Clinical Legal Education: To strengthen the Clinical Legal Education, the University has an office of the Legal Aid Clinic on the main gate of the University. In addition to the</p>		

Campus Legal Aid Clinic, the University has Legal Aid Clinic in Dompada village, Cuttack. These Clinics are providing help to the inhabitants of nearby vicinity in reaching the services of District Legal Services Authority and State Legal Services Authority. The clinical Legal Education is an important course for the students where the regular field visits are undertaken.

<p>As the part of the inter-disciplinary approach, study of law is combined with Sociology, Political Science, Economics, Language and Literature in UG level courses. It combines the study of law with management and finance. NLUO also offers Ph.D. programme on inter-disciplinary subjects fulfilling all the requirements prescribed by UGC including course work for one year, six months progress report, pre-submission presentation and open viva.</p> <p>NLUO offers B.A.LL.B., B.B.A.LL.B., B.A. (Law) Programmes at undergraduate level. In addition to the subject recommended by Bar Council of India, the additional subjects are also being offered to the students. B.A.LL.B. Programme includes the social science subjects including Law and Language, Introduction to Political Science, Legal History, Law Literature and Films, Contemporary Political Discourse, Architecture of Social Life, Sociology of Social Issues & Debates, Global Politics and Governance, Microeconomics, Organizational Behaviour, Basic Principles of Accounting, Macroeconomics, Economic Development and Planning in India, Sociology of Social Transformation etc.</p> <p>Likewise the B.B.A. LL.B. Programme covers the social science subjects including Law and Language, Basic Principles of Accounting, Law, Literature and Films, Introduction to Political Science, Cost and Management Accounting, Corporate Accounting, Principles and Practices of Management, Organizational Behaviour, Human Resource Management, Fundamentals of Marketing Management, Business Economics, Introduction to Sociology, Strategic Management etc.</p>	

B.A. (Law) Programme also focusses on interdisciplinary approach towards different courses. It has papers of Legal Counselling, Law and Entrepreneurship, Advocacy, Legal Profession Assistant and Legal Journalism.

18.Academic bank of credits (ABC):

The University has adopted ABC system for the benefit of students and their academic growth. Students have started enrollment on the ABC portal and proper procedure thereof has been laid out on the university website.

19.Skill development:

NLUO offers B.A.LL.B., B.B.A.LL.B. and B.A. (Law) programmes at undergraduate levels and LL.M. programme at post graduate level. These programmes are professional courses with an objective to provide technical knowledge in the field of law. To promote technical and practical knowledge, NLUO offers elective courses. In addition to this, NLUO also offers courses of different weightages like credit courses, certificate courses and field visits. The students also participate in different competitions including debate competitions, moot court competitions to sharpen their argumentative and research skills.

As a Law University, NLUO focusses on Clinical legal education as an important component of evaluation for third year students. Alternate Dispute Resolution is a compulsory course which focuses on developing the negotiation, mediation and conciliation skills of the students.

The University also has Trial and Advocacy course which focuses on practical aspect of advocacy skills such as chief and cross examination of witnesses and client counselling. Additionally, we have the Law and Entrepreneurship Course which enables the students to understand the nitty-gritties of practical world of an entrepreneur. NLUO continuously arranges the programmes with different subject experts, professors, advocates, policy makers and judicial officers. These programmes helps the students to know about the practical challenges in the profession and helps to sharpen their technical knowledge.

20.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

NLUO integrates the knowledge of Indian culture by providing the practical trainings and field visits to the students. Several courses are undertaken for the students to integrate the Indian culture. The University offers Environmental Law, Legal History, Human Rights, Jurisprudence, Literature and Films, Sociology,

Introduction to Political Science, Tribal Identity and Forest Rights in India. In addition to this, the faculty members integrates the knowledge of Indian culture in their respective courses.

NLUO has also integrated the local art, crafts, and cultural aspects in our courses especially in courses on Intellectual Property Rights, Criminal Law and Personal Laws. The research centres also play an important role in providing the knowledge to the members and general masses about different areas.

The students of the undergraduate courses are offered a course on Legal History where students are exposed to the origin of law from various religious texts like shastras, upanishads etc. The course of Environmental Laws, provides knowledge about the environmental consciousness in India during the Vedic times and in ancient India. To promote the Indian culture of Yoga and meditation, the students are encouraged to learn these traditional skills for which University conduct workshops every year.

Additionally, NLUO organises film screenings where films from various regions of the country are screened and discussed. The library of University provide newspapers in different languages including English, Hindi and Odia.

21.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

The University focuses on outcome-based education. The course outlines are drafted with an objective of holistic development of the students. As a professional University, NLUO provides focussed learning to cater the needs of the students. The students are provided with the internship break after each semester to join the law firms, NGOs, chambers of advocates practicing at different courts, tribunals, judicial internship and other offices to learn the practical aspects of the subject. The outcome of the courses are designed taking into account the professional and local needs.

22.Distance education/online education:

NLUO is continuously working to enhance teaching-learning experience. To promote online education, the University organises several webinars on regular basis. NLUO conducted a guest lecture on the topic State of Legal Education in India - Social Relevance, Accessibility and Inclusivity delivered by Mr. Rahul Bajaj and Mr.

Husain Aanis Khan. Mr. Bajaj is an attorney at Ira Law and a Senior Associate Fellow at Vidhi Centre for Legal Policy, an International Webinar on Law and Development was held, featuring Prof. Yong Shik Lee, Director and Professorial Fellow at the Law and Development Institute and Visiting Professor of Law at the University of Nebraska College of Law.

National Law University, Odisha is successfully running an annual online certificate course on Climate Change - Law, Justice and the Global South organised by NLUO's Centre for Research and Management of Natural Resources (CRAMON) in association with Law, Environment and Development Centre (LEDC) and SOAS University of London.

National Law University Odisha's Constitutional Law Society (NLUO - CLS) has organized four distinctive courses to cater to the academic needs and interests of its participants. These courses include the "Drafting Certificate Course on Quintessence of Constitution: Public Interest and Public Policy (Supreme Court Practice and Procedure)," the "Certificate Course on Supreme Court Practice and Procedure: Writs, PILs, Appeals, and Special Leave Petitions," the "Credit Course on The Economics of Constitutionalism: Principles and Practices," and the "Certificate Course on Judicial Accountability: Structure, Reforms, and Challenges."

In addition to the above, the National Law University Odisha (NLUO), jointly with the Cyber Law University, presented an "Online Certificate Course on Cyber Law and Cyber Security."

and LL.M. programmes, the University emphasises on an in depth understanding of the laws, rules and regulations at the local, regional, national and international level. This is ensured at the course design presentations before the beginning of every semester and before the course designs are circulated to the students.

Clinical courses offered at the university such as legal aid, ADR together with its outreach programs keep the students connected with the local and regional issues. University offers B.A. Law course which largely caters to requirements and skill development for local students. Special subjects offered like Public Health Law, Access to Medicine and Patents, Child Rights, Disaster Management Law, Water Law, Election Law etc. in addition to compulsory courses like Constitutional Law and Criminal Laws keep the students abreast with the national political, economic and social issues.

The University also has extensive courses that are relevant to global developments. Some of the courses that may be highlighted here are International Trade Law, International Investment Law, Environmental Law, Public International Law, International Humanitarian Law, Theory and Constitutionality of Terrorism Laws, Maritime Law, International Taxation, Commercial Arbitration, Comparative Judicial Reforms etc.

The curriculum is developed taking into account the local, national, regional and global developmental needs. All these needs are reflected in the Programme Outcome, Programme Specific outcome and course outcome. The details are available on the website of NLUO.

1. Compulsory course on Professional Ethics and a clinical course on Trial and Appellate Advocacy aims at building professional ethics in the students. Course on 'Alternate Dispute Resolution' instils human value of amicable problem solving.

2. Clinical course on 'Legal Aid and Drafting, Pleading and Conveyancing includes filed visits by students to identify various societal problems and explore legal solutions.

Gender:

1. 'Gender and Law' is offered to PG students.

2. Discussions on gender and inclusiveness are situated as a part of some of the BCI mandated courses at the under[1]graduate level like Sociology, Human Rights, Constitutional Law, Personal Laws, Labour Laws etc.

3. Elective course on 'Public Health Law' incorporates issues like reproductive health of women.

4. Clinical Legal Education' (CLE) students are encouraged to identify gender issues.

Environment and Sustainability

1. Compulsory course on Environmental Law is offered to the students of undergraduate course as per the mandate of BCI.

2. Faculty is encouraged to incorporate sustainability discussions in their outline. Example of such courses are integrate issues of sustainability are water law, public health law, biotechnology and law, international trade law, international investment law, law and justice in a globalised world, energy law, infrastructure law.

3. Discussions on sustainability is included in courses like Microeconomics, Macroeconomics, Strategic Management.

The University ensures implementation of promotion schemes to ensure that faculty members are not stuck in the same cadre.

Relaxation in teaching workload is provided on a case-to-case basis to faculty members who are in critical phases of their Ph.D. submission. Faculty members are encouraged to develop optional courses in areas of their interest and expertise.

Travel Grant Policy has to be formulated to provide financial support to faculty members who are participating in national and international conferences, seminars and workshops. A Publication Incentive Scheme has also been formulated which provides financial incentive to faculty members for each publication of articles in journals listed in UGC Care List or indexed in SCOPUS. To promote the mental wellbeing of faculty members, the University has facilities of accessing counselling in person and also online counselling services which the faculty can avail.

- The University has Legal Aid Society, Pro Bono Club, UBA Society, NSS Units and Mediation Clinics which equip students in extension activities and community outreach programmes enhancing their knowledge on the field as well.
- The University has established NLUO Incubators Forum under the aegis of Institute Innovation Council. In addition to this, a

compulsory course on Law and Entrepreneurship is also offered to the students.

Extension activities in the neighbourhood community are conducted through the following student bodies and societies. The detailed activities are outlined in the Annual Report.

- **Legal Services Committee:** The Legal Services Committee aims at promoting access to justice through various extension and outreach activities such as legal literacy programmes in schools, child care institutions, orphanages, senior citizen homes and community legal awareness drives.
- **NSS Bureau:** The NSS Bureau aims at general welfare of local communities and makes interventions like health camps, cleanliness drives, plantation drives etc.
- **Project Kutumb:** This project focuses on the welfare of children in adopted villages (Brajabeharipur, Balmikinagar (Mundasahi) & Babatilakanagar) and aims to develop indicators to assess child-friendliness of villages. The students under this project conduct door to door survey and regular meetings with stakeholders in the villages to understand the issues and concerns from a child welfare perspective.
- **Unnat Bharat Abhiyan (UBA):** The UBA cell of the University has adopted five adjoining villages and aims to enrich the status of living in the five villages through structures community outreach programmes like medical camp, career counselling and guidance to students of the village, conducting Gram Sabha etc.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The institution has adequate facilities for teaching - learning. viz., classrooms, laboratories, computing equipment, etc.

- **Classrooms:** The institution has a total of 40 air-conditioned classrooms, with teachings and ICT tools like smart boards with audio visual facility, seamless Wi-Fi connectivity, projectors, and other teaching tools like white boards, podium etc.
- **Other physical facilities for teaching learning:** The University has the following facilities: 1 moot court hall of 120 seating capacity, 2 conference halls of 50 and 20 seating capacity, 1 amphitheatre with 1,100 seating capacity, 1 seminar hall with 150 seating capacity and one dedicated incubation centre.
- **Library and e-resources:** The library is spread over an area of 45000 sq.ft. and consists of an ebrary with 14 computers for student use and a conference room/meeting room. The library is rich with e-resources (29) and books.
- **Teaching - learning for slow learners and differently abled:** Differently-abled students are provided with an additional aid

during examinations like scribes. Likewise, special attention is given to slow learners through mentorship schemes.

- **Computing equipment:** State-of-the-art information technology tools, data Centre and Network Operation Centre are in place to take care of computing and communication needs of NLUO.

4.1.2 - The institution has adequate facilities for cultural activities, yoga, games (indoor, outdoor) and sports. (gymnasium, yoga centre, auditorium, etc.)

The University has taken several initiatives for developing the sports infrastructure, promoting cultural and other activities.

Sports facilities: In terms of infrastructure, the University has a cricket ground (18,585 sq.mtrs) and football field (66m x80m dimension) for use by students and staff members. There are 2 two basketball courts (29.3m x 14.6m dimension), one tennis court (24m x 11.1m dimension) and one volley ball court (19m x 9m dimension). Additionally, there are 2 badminton courts in each hostel and provision for indoor games like carrom, table tennis, chess etc. A student sports committee is constituted for upkeep and management of sports related resources in the University.

Cultural activities: For furthering cultural activities, the University has an amphitheatre and open arenas for conducting annual cultural events. There is a student run Cultural committee to conduct cultural events in the University. There are multipurpose rooms in hostels for musical and sports equipment.

Other facilities: There is one common Gymnasium of 128.48 sq mtr size. There are specific timings for male and female visitors. The University has a well-developed amphitheatre with 1,100 seating capacity, equipped with three LED screens where all big cultural events take place including convocation.

§ **Academic facilities:** There is a separate dedicated building, the Academic Block for academic activities. It has a seminar hall with 200 seating capacity and a moot court hall for mock trial exercises.

§ **Residential facilities:** There are four hostels inside the campus (2 boys hostel and 2 girls hostel) providing single room accommodation to all students from their 2nd year of study. The hostels also have 24 x 7 presence of hostel staff .

§ **Health facilities:** The University has a Wellness centre, staffed with two doctors and three qualified nurses, with nurse available 24 x 7 and there is a full-time certified counsellor appointed. There are two ambulances available on the campus for use 24 x 7.

§ **Recreational facilities:** There is one Nescafe kiosk, one juice centre, one canteen/cafeteria and one stationery shop for convenience of students.

§ **Green campus facilities:** The University has made its campus green by planting different species of trees with the help of State Forest Department, Municipal Corporation and Horticulture committee.

§ **Facilities for specially abled:** To facilitate movement of specially abled, there are tactile path and provision for lifts and ramps in the academic block and administrative block of the University.

4.2 - Library as a Learning Resource

- Library has been automated using integrated library management software (ILMS) KOHA (version 20.11) and RFID Technology. It provides a comprehensive set of tools for various library tasks, including cataloguing, circulation, acquisitions, and more. Further through Refread portal, students and faculties can access library e-resources from their systems.
- Koha provides a web-based interface, making it accessible from any device with an internet connection. This facilitates remote management and access to library resources. The OPAC is available over internet through intranet, through which the users can check the availability of books, titles and numbers in the library and whether they are available or already issued to another student/staff. Users can reserve their desired books through the software if it is already issued and get an alert when the book is returned to the library. Users can check their circulation history through the software.
- The issue and return are done with the help of RFID staff station. The overdue fines are collected through the library management software and the issue, return of books/journal etc. and overdue notices are also sent through the software.

The NLUO Act, 2008 has identified composition of the University in section 3 as Chancellor, Vice-Chancellor, General Council, Executive Council, Academic Council and the Registrar. Section 10 has identified the authorities of the University to include Finance Committee along with those mentioned earlier. At NLUO the leadership while maintaining accountability has ensured existence of trickle down management system allowing for complete decentralisation. The organogram (as attached) indicates the structural decentralisation as followed by the institution.
