PREFACE

National Law University Odisha, Cuttack nestled amidst the lush greenery at the confluence of mighty rivers Mahanadi and Kathajodi, has in a short span of time made a name for itself as an institution par-excellence devoted to the goal delivering socially responsible, intellectually simulated and research oriented lawyers to the country. NLUO has established itself as a force to reckon with in the sphere of legal research, teaching pedagogy, industry desired curriculums, and outreach programs creating a holistic nurturing environment for the NLUO students to develop into aware, capable, sought after and sensitive students ready to face the challenges of the world while making it a better place to live.

Over the last decade NLUO students have made a mark for themselves by registering wins in some of the most prestigious moot court competitions in India and abroad. Our meritorious students can be found at different positions in law firms, chambers of senior advocates, central and state civil services and judicial examinations across the country. NLUO celebrates merit and thus disburses merit-cum-means scholarships annually to the tune of INR 18,00,000/- for meritorious and deserving candidates. Besides providing financial support NLUO provides a vibrant campus with ample opportunities for growth and recreation through various activities allowing for balanced and holistic development of its students. This is visible from the success of NLUO students at various sporting, cultural and musical events held across the country. Most importantly NLUO has proved itself to be a gender sensitive institute with more girls opting for NLUO than before. As per the last admission statistics in 2023 out the 260 admissions that took place 151 were girls and 109 were boys. This is a monumental achievement for NLUO. This was made possible due to NLUO's strong commitment to gender equality and social diversity initiatives adopted over the past few years.

Similarly, with over 30 administrative committees, 25 research centres and equal number of student run committees, research oriented activities beyond academics led by faculty members have helped not only develop quality research but to train students develop a simulating and invigorating exploratory intellect. NLUO is functioning at an equal footing with any mid-sized multi-department university. It is commendable that the faculty and staff of NLUO are looking at growth and expansion of NLUO in a unified single goal oriented manner. There were more than 15 new credit cum certificate course that were introduced in addition to the existing 7 regular courses. These value added courses have been taught over and above the existing theoretical courses in order to provide students better exposure and industry ready skill set. Thus apart, NLUO conducted various events of repute both national and international which have helped disseminate NLUO's work worldwide. NLUO organized the 9th Conference of the International Society for Child Indicators: Global Childhoods: Critical Perspectives Promoting Theoretical, Empirical and Policy Understandings which witnessed a participation from nearly 100 countries of the world. NLUO has been organizing international moot court competitions, ADR competitions for academic growth of its students, while organizing sports and cultural events in line with the commitment for holistic development of the students.

It is worthwhile to note that the modest team of 60 faculty members have over the last one year have made NLUO proud in terms of individual academic achievements. The year 2023-24 saw production of 7 books by NLUO faculty members. More than 50 publications in national and international journals of repute, participation in nearly 100 conferences both as presenters as well as resource persons. This year also witnessed in a spurt in self-teaching and learning activities by faculties with nearly 100 training programs being attended by the members of NLUO community both as participants as well as subject experts. To add to these achievements, it is NLUO's pride that our Hon'ble Vice Chancellor was recognized as one of the Most Influential Women in Law by BW Legal, for a second consecutive year. Further Dr. Neeru Chadha, NLUO's Honorary Professor, was appointed as the Vice-President of International Tribunal for the Law of the Sea.

NLUO faculty and students have dedicated themselves to the cause of the lesser privileged members of the society through outreach programs, legal awareness camps and conducting socially relevant research for improving the station in life of the members of the society as is witnessed in Project Kutumb. NLUO's Legal Aid Clinic receives numerous complaints and requests for resolution of disputes. To this end NLUO's ADR Board also a recipient of the coveted PACT and Maadhyam Award by International Council for Conflict Resolution, has successfully helped out of court settlement for numerous members of communities surrounding NLUO. To further the cause of the outreach and exposure for students as many as 50 MOUs have been executed by NLUO over the past few years with nearly 20 still in force. The Year 2023 marked the 10th convocation of NLUO which was presided over by Hon'ble President Draupadi Murmu, a stamp of approval to the exponential rise of National Law University Odisha. Other guests of honour included Prof. Ganeshi Lal, Hon'ble Governor of Odisha, Hon'ble Justice (Dr.) S. Muralidhar, Chief Justice, Orissa High Court and Chancellor, NLUO, Shri Jagannath Saraka, Hon'ble Cabinet Minister, Department of Law, Government of Odisha, and Hon'ble Mr. Justice Subhasis Talapatra, Judge, Orissa High Court. Sitting Judges of High Court of Orissa, Senior Advocates, Judicial Officers also graced the occasion. During the convocation nearly 20 Gold medals were awarded in 2023. At the Tenth Convocation, total of 223 graduands were awarded degrees, including 4 Doctorate Degrees, 42 LLM candidates. It is my honour to present the 11th Annual report showcasing the achievements and most importantly the hard-work of NLUO family.

ABOUT NATIONAL LAW UNIVERSITY ODISHA

National Law University Odisha has been set up by Government of Odisha under the National Law University Odisha Act, 2008. It is located at Cuttack nestled in the lap of nature between the mighty Mahanadi and Kathajodi rivers. NLUO has over the years established itself as a Centre for Excellence in research, legal education and social outreach programs. At present NLUO has 4 undergraduate programs, 2 post-graduate programs, 1 Ph. D program, numerous credit courses and 200 courses taught in the programs mentioned hereinbefore. At NLUO at any given point in time there are about 1000 students on campus with on an average 200 graduating every year. NLUO has nearly 60 faculty members and administrative assistance of nearly 100 members.

At NLUO delegated accountability is practiced in administrative decision making with the help of Student Council, autonomous student run mess and student representation on all disciplinary and academic committees. At NLUO there are about 30 administrative committees which assist the management in managing the University in the most efficient and effective manner. NLUO maintains academic rigour in the form of extensive, comprehensive and sporadically changing course curricula in line with suggestion from the industry leaders and alumni and an equally extensive evaluation mechanism. At NLUO there is tremendous emphasis on understanding the practical aspects of legal theory which is achieved through development and deployment of clinical legal education courses on Professional Ethics, Trial and Appellate Advocacy, Legal Aid etc.

Research is carried out through 25 research centres and an equal number of student run committees with continuous research activities conducted by NLUO in varied areas of Domestic Violence, Prison Administration, Tobacco control etc. Many projects are undertaken by students either of their own violation or at the behest of the faculty members allowing for wide range of projects and unique results. The faculty members are encouraged by the University to continue with a generous corpus of seed finding being kept reserved for the purpose.

NLUO is desirous of inculcating in students a sense of social responsibility which is indicated through various regular and optional outreach programs undertaken by the institution making it mandatory for students to atleast be part of one initiative so as to be able to appreciate the grassroots, the life styles, difficulties and lack of access to resources faced by the lesser privileged members of the society.

NLUO encourages recreation after achievement of academic prowess as is reflected through the organization of various sporting, cultural and culinary festivals on the NLUO campus. National Law University Odisha creates an enabling environment ensuring all-round development of its students while allowing for ample growth of its staff and faculty members in the professional sphere towards achieving the goal of becoming the *Centre of Excellence in Eastern India*, a one of its kind institution.

OUR LOGO

National Law University Odisha's logo is in the form of an escutcheon (heraldic shield) divided into four quarters, colored blue and white alternately. On the top left quarter is a balance representing the scales of justice. On the top right quarter is a gavel representing the might of the judiciary. Just below them, across the Nombril Point, runs a scroll bearing the inscription 'National Law University Odisha'. Below this is a representation of the Indian Constitution. Superimposed on the center of the shield, centering on the Fess Point, is a *Chakra* or wheel from the Sun Temple at Konark, which represents the State of Odisha.

OUR MOTTO

National Law University Odisha's motto has been sourced from *Kautilya*'s *Arthashastra*, one of ancient India's great texts. In Chapter III, Book 1, *Sloka* 39, four varieties of law are identified, namely *Dharma* (sacral law), *Vyavahara* (transactional law), *Caritra* (customary law), and *Rajasasana* (royal edicts). *Sloka* 40 determines the source of each type. In this context the book asserts, 'satye sthito dharmah' or 'Law locates in the truth'. This precept is as valid today as it was in *Kautilya*'s times.



VISION AND OBJECTIVES

The vision of National Law University Odisha is to develop as a *Centre of Excellence in Legal Education* and emerge as a place of professional learning while nurturing the idea of serviceability to the people. In order to translate this vision into reality, the University orients students to cater to the needs of the society by developing the professional skills to take up the professions of advocacy, judicial service and legal services. The University has an excellent academic ambience that nurtures young minds to critical legal scholarship, in the atmosphere of a modern *Gurukul*, in the lap of nature. The academic curriculum, pedagogy and teaching methods at National Law University Odisha, make coordinated efforts to ensure holistic perspective amongst the students. The preamble to the National Law University Odisha Act (Act 4 of 2008) outlines, its long-term goals as follows:

- advancement of the law through learning, teaching, research and diffusion of knowledge in the field of law; and
- catering to the needs of the society by developing the professional skills of those
 intending to take up the professions of advocacy, judicial services, legal services and so
 on.

Taking inspiration from this, the University identifies and pledges adherence to the following objectives:

- to design and run regular and periodical courses of learning for dissemination of knowledge, advanced learning in legal subjects and issues of law and other related disciplines with a view to meaningfully integrate, support and enhance professional knowledge of law and to appreciate the role of rule of law in national growth and development;
- to develop in the students and scholars social and scientific research skills for enhancing a sense of responsibility to serve the society as a professional and develop a temperament for reformation, justice delivery and law making while developing professional skills of advocacy and legal services;
- to advance the professional education in convergence with knowledge of other related disciplines so as to provide adequate orientation and training including facilities of continuing education to law teachers, judicial officers, advocates and other persons in the civil society engaged or interested in legal field involved in the administration of justice; and
- to organize lectures, seminars, symposia and conferences, to promote legal knowledge and to make law and legal processes as efficient instruments of social development.

Hon'ble Mr. Justice Sanjeev Khanna

Judge, Supreme Court of India Visitor to National Law University Odisha

Hon'ble Mr. Justice Sanjeev Khanna, was born on May 14, 1960. After enrolling as an advocate with the Bar Council of Delhi in 1983, he began his practice in the District Courts at Delhi, moving subsequently to the High Court and the Supreme Court. During his illustrious career as a lawyer he was appointed the additional public prosecutor, amicus curiae, standing counsel for the Income Tax



department and National Capital Territory of Delhi. Justice Khanna has practiced in various niche areas of law including medical negligence, environmental law, arbitration, direct taxes amongst others viz: Constitutional Law and Civil Law. He was appointed as Judge to the Delhi High Court in 2006 and was elevated to the Supreme Court in 2019.

CHANCELLOR

Hon'ble Mr. Justice Chakradhari Sharan Singh Chief Justice, Orissa High Court

Chancellor, National Law University Odisha

Born on January 20, 1963, Hon'ble Mr. Justice Chakradhari Sharan Singh was enrolled as an Advocate on 30.10.1990 after having obtained LL.B. Degree from Campus Law Centre, Faculty of Law, University of Delhi. He practiced mainly in Service, Constitutional, Criminal, Taxation and Labour law matters. He has served as Additional Standing Counsel for Central Government, a panel



counsel for Comptroller and Auditor General of India in Patna High Court. He was also empaneled at the Patna High Court on the Administrative side. He received training as mediator in 2006 and was appointed mediator for Patna High Court Mediation Centre. He was designated Senior Advocate with effect from September 18, 2010. He was appointed as the Additional Advocate General, Govt. of Bihar in December, 2010 and continued as such till his elevation as an Additional Judge, Patna High Court in April 2012. His lordship was the Acting Chief Justice, Patna High Court from February 6, 2023. On being elevated as the Chief Justice of the Orissa High Court, he took oath on February 7, 2024.

UNIVERSITY ADMINISTRATION

Prof. Ved Kumari

Vice-Chancellor, National Law University Odisha

Professor Ved Kumari is the former Dean and Head, Faculty of Law, University of Delhi and Director of Delhi Judicial Academy. She began teaching law in 1983 and has taught graduate and undergraduate courses at the University of Delhi, Jammu University in India, and Vanderbilt University (USA). She has written many books and innumerable articles in national and international journals.



Professor Ved Kumari's primary areas of academic interest are juvenile justice, criminal law, gender discrimination, clinical legal education, and judicial training. She introduced an innovative full-semester course at the University of Delhi as part of Course Work for research scholars on 'Andragogy – the Art of Teaching Adults' aimed at training future law teachers in adult teaching methods and improving the learning of students. She is a Fellow of Commonwealth Judicial Education Institute, Canada (2010); Commonwealth Fellow at Warwick University, UK (1998); and Fulbright Fellow at Vanderbilt University, USA (1997). She spent one year in Russia doing research on the Law and Advocacy in Relation to Children in Russia as part of her sabbatical leave in 2005.

Prof. Rangin Pallav Tripathy

Registrar, National Law University Odisha

Prof. Rangin Pallav Tripathy has been teaching at National Law University Odisha since 2010 and works in the area of constitutional governance, civil liberties, criminal law and human rights. His current research focuses on the functioning of institutions within constitutional democracies and the way they affect the realization of democratic rights. He was a Fulbright Post-Doctoral Research Scholar at Harvard Law School (2019-2020) where he researched the competing methods of appointing judges in democracies.



He has completed two research projects funded by the Department of Justice, Government of India in the area of judicial reforms. He has also provided consultancy services to Odisha Judicial Academy for the preparation of research materials for judicial officers.

ACADEMIC PROGRAMMES

National Law University Odisha offers a wide range of courses in its vision to becoming the Centre of Excellence for Legal Education. National Law University Odisha offers six regular courses as listed below. These are in line with the mandate provided by the Bar Council of India as well as University Grants Commission. Significant efforts have also been made to gradually incorporate the New Educational Policy of Government of India within the curriculum as well. Apart from the six regular courses NLUO offers a wide range of short term certificate and credit courses which empower the students to learn beyond the regular prescribed courses. These courses offer the students the opportunity to learn practical implications of the legal procedures studied alongwith linkages with other subjects from industry experts themselves. These additional courses provide great many options to students to explore newer areas of law without the fear of losing out on specialization in traditional courses. Thus a balanced understanding and industry readiness is witnessed amongst NLUO students.

The regular courses offered by the University include:

- i. BA LLB(Hons)
- ii. BBA LLB(Hons)
- iii. BA Law Programme
- iv. 3 Year LLB Programme
- v. LLM
- vi. Ph D

BA LLB(Hons) and BBA LLB(Hons) Course

The University offers two five-year integrated undergraduate programmes in law, namely BA LLB (Hons) having a total of 120 seats and BBA LLB (Hons) having a total of 60 seats. The BA LLB (Hons) programme combines the study of law with social sciences. As part of the interdisciplinary approach, courses on Sociology, Political Science, Economics, etc. are taught under the social sciences discipline. The BBA LLB (Hons) combines the study of law with management and finance. It offers foundational courses like Principles of Accounting and Organizational Behaviour and focusses on importance of integration of facets of social sciences and management with law. In the year 2023 out of 171 admissions 100 were girl students and 71 were boys, with more students from outside of Odisha taking admission than local domiciled students.

BA Law Programme

The BA Law Programme started in the Academic year 2022-23 and offers five specialized vocational streams connected with law and legal profession having a total of 50 seats. In view of the National Educational Policy (NEP) 2020 suggesting 'job ready' courses with multiple entry and exit points this course has been conceptualized. Course is being offered in five streams i.e. Legal Counselors, Legal Journalism, Advocacy, Legal Profession Assistants and

Law and Entrepreneurship. It is worthwhile to note that all the candidates in the course are local natives of Odisha.

LLM

National Law University Odisha offers a unique LLM program to the students who wish to pursue post graduate studies in the field of law. While primarily specialization in Constitutional Law and Corporate Law is being offered, NLUO has the rare distinction of permitting interdisciplinary research during the LLM course, allowing the students an opportunity to explore untouched vistas of law. In the year 2023 even the post graduate admissions witnessed larger success of girls with 25 girls securing admission in comparison to 20 boys.

3 Year LLB Programme

3 Year LLB has been introduced in the year 2023 as part of the University's vision for expansion. 60 seats have been earmarked for the course. In this course in the year 2023 NLUO witnessed admission by 26 girls in comparison to 18 boys in the same batch.

PhD

National Law University Odisha places immense value on the pure scientific research in the legal sphere as is evident from the various projects that NLUO has in the past been recipient of. This focus gets translated in the PhD program as well where the scholars are encouraged to research on unique aspects of law. The scholars have also been permitted inter-disciplinary research in order to better appreciate the inter-linkages between subjects within and outside the law.

Given below is the admission data of the students admitted to National Law University Odisha, in the year 2023. This indicates that not only has there been an increase in the number of girls qualifying the CLAT examination but also that NLUO has had the opportunity to witness this skewed ratio in favour of girls.

NLUO Scholar in Residence Program

National Law University has a regular exchange of Fulbright Scholars for the faculty in residence in program. Over the last two years NLUO has been home to two Fulbright Scholars, Warren Burke and L. Denice Labertew.


SHORT-TERM COURSES OFFERED BY NATIONAL LAW UNIVERSITY ODISHA

1. PG Diploma Course on Rehabilitation and Correctional Administration

The PG Diploma Course on Rehabilitation and Correctional Administration offered by National Law University Odisha, in collaboration with Director General of Prisons and Correctional Services, Odisha as part of the MOU executed between NLUO and DG Prisons, Odisha. It aims to give a holistic overview of the criminal justice administration, prison and correctional administration and rehabilitation. It aims to combine approaches of law, criminology, victimology and psychology in one single course. Through this course, it is intended to introduce the learners to the basic concepts of prison administration, crime causation, sentencing policies, concept of punishments, aspects of victimology and restorative justice.

2. Certificate Course on Climate Change – Law, Justice and The Global South

A Certificate course on Climate Change – Law, Justice and The Global South was organized by the Centre for Research and Management of Natural Resources (CRAMON), National Law University Odisha, in association with Law, Environment and Development Centre (LEDC), SOAS University of London. This course aimed to provide a critical understanding of the legal regime on climate change and introduce a justice perspective from the point of view of marginalized countries and people. It is part of the National Law University Odisha's and SOAS's initiative to disseminate awareness about climate change law and related justice issues.



3. Online Certificate Course on Cyber Law and Cyber Security

National Law University Odisha (NLUO) jointly with the Cyber Law University presents "Online Certificate Course on Cyber Law and Cyber Security." The course aims to disseminate knowledge regarding the constantly evolving trends impacting cyberspace and connected paradigms. It covers a diversified arena connected to cyber law and intellectual property rights, artificial intelligence law, blockchain technology etc. This course has been designed, conceptualized and developed by Dr. Pavan Duggal, Advocate, Supreme Court of India and Honorary Chancellor, Cyber Law University.

4. A Single Credit course on Adjudication of Housing and Land Rights

Online Single Credit course on 'Adjudication of Housing and Land Rights' was conducted by the Centre for Research and Management of Natural Resources conducted in collaboration with Housing and Land Rights Network. The course was conducted over a period of three months.



5. Single Credit Course on the subject of Gendered Justice

Single Credit Course on the subject of Gendered Justice was conducted by Centre for Woman and Law of National Law University Odisha. The course was taught by Professor L. Denice Labertew, Juris Doctor of Human Rights, during her visit to India as part of the Fulbright scholarship. The course was conducted between July 29 to August 9, 2024.

6. Double credit course on Introduction to WTO Jurisprudence

National Law University Odisha's Center for International Trade Law is offering a 2 credit course on 'Introduction to WTO Jurisprudence' to be conducted over a period of 40 days, starting in July 2024. The course is being conducted by Prof. (Dr.) Sheela Rai. The course is one of a kind course which not only delves into the mysteries of functioning of the

WTO but also throws light on the contemporary issues plaguing the international organization.

7. A Single Credit Course on Negotiation and Mediation Training

A Single Credit Course on 'Negotiation and Mediation Training' was conducted jointly by Centre for Public Policy, Law and Good Governance (CPPLGG) and Centre for Mediation and Negotiation (CMN). The course was conducted on February 24 and February 25, 2024 by Mr. Mohit Mokal.

8. A single credit course on the subject of Contract Drafting

A single credit course on the subject of 'Contract Drafting' was organised by the Centre for Corporate Law. The course continued for five days from February 21 to February 25, 2024. The course was taught by Shree Bhumesh Verma, Managing Partner of Corp Comm Legal.

9. A certificate course on Pharmaceutical Industry, Public Health, and Intellectual Property Rights

IPAAC of National Law University Odisha conducted a single credit certificate course on Pharmaceutical Industry, Public Health, and IPR in October- November 2023. The resource persons for the course were Prof. Dr. Reji K. Joseph, from Institute for Studies in Industrial Development, New Delhi. This course aimed at studying the pharmaceutical industry in the context of public health crises, especially in developing countries like India and to familiarise the students with the dynamics of the linkage between pharmaceutical industry and public health touching upon economic, legal, and public policy issues.




10. Single credit course on Procedures and Practices of International Commercial Arbitration

A single credit course on the subject of 'Legal Foundations for Technology, Innovation, and Entrepreneurship: Navigating the Digital Era' was conducted by LexTech: Centre for Law, Entrepreneurship and Innovation. The duration of the course spanned from March 8 to March 10, 2024. The course was conducted by Prof. Nikhil Naren, Assistant Professor, Jindal Global Law School.

14. 5th CLS Credit Course on Equality Jurisprudence and Legislative Drafting

The Constitutional Law Society of National Law University Odisha successfully organized the 5th edition of its Certificate Course on the topic of 'Equality Jurisprudence and Legislative Drafting'. The Course Instructors were Dr. Seema Singh, Professor, University of Delhi, Mr. Colin Gonsalves, Senior Advocate, Supreme Court of India, Ms. Ushashi Datta, LAMP fellow and lawyer, Hon. RESEARCH PROJECTS AT NATIONAL LAW UNIVERSITY ODISHA

At National Law University Odisha, a lot of focus is laid on the research activities in line with its commitment to fostering research. Thus NLUO is engaged in many research activities in collaboration with other organizations and institutions including government agencies and regulatory bodies. For promoting research amongst the faculty members, NLUO has also initiated a seed fund grant policy wherein the faculty is offered a seed fund grant to conduct research on the subject of their choice. This initiative is aiding fostering of research culture at NLUO.

1. Project on Evidence-Based Tobacco Control Initiatives

Supporting Stronger and Evidence-Based tobacco control initiatives through capacity building and strengthening laws, policies and international mechanisms with multi-stakeholder engagement for tobacco-free India awarded by International Union Against Tuberculosis and Lung Disease is being funded by Vital Strategies.



NLUO through this project aims to strengthen its mission of eradicating tobacco use and abuse through policy and action oriented intervention. Prof. Rangin Tripathy and Dr. Rishika Khare are incharge of the project.

Project on Addressing Domestic Violence in Odisha through Institutionalised Domestic Violence Response Protocols awarded by Human Rights Fund (2023-2025)

The National Law University Odisha entered into an agreement with the Netherlands Embassy to implement a project titled *Addressing Domestic Violence in Odisha through Institutionalised Domestic Violence Response Protocols*. The Project is funded by the Human Rights Fund. The project is for a period of two years and is led by Prof. Rangin Pallav Tripathy and Dr. Suman Dash Bhattamishra. The project aims at establishing institutionalized domestic violence response protocols in the state of Odisha to enhance the victims' access to justice.

3. Project on Social Protection of Women Migrant workers in Odisha by National Commission for Women

In continuation of the work done by National Law University Odisha on status and position of migrant labour specially during COVID-19, the University has partnered with National Commission for Women, Ministry of Women and Child Development to conduct a detailed survey pertaining to the social protection accorded to the migrant women labourers. The project also aims at identifying areas wherein socio-legal interventions may be possible. Dr. Sohini Mahapatra, Ms. Rishika Khare, and Nikita Pattajoshi are associated with the project.

4. Project on Women's Safety Audit in the City of Asansol awarded by National Commission for Women

In partnership with National Commission for Women, Ministry of Women and Child Development, National Law University Odisha is conducting a safety audit in the city of Asansol. Prof. Ved Kumari, Vice Chancellor, NLUO is leading the project. The other faculty members involved in the same are Prof. Sheela Rai, Prof. Rangin Pallav Tripathy, Dr. Arjyalopa Mishra and Dr. Priyanka Anand.



5. Project on Social Mapping of Migrant Workers in Odisha (Phase II) by Labour and ESI Department, Government of Odisha

Continuing with research on migrant labour a second project has been initiated in partnership between National Law University Odisha with the Ministry of Labour and ESI department for conducting a social mapping of migrant labour in Odisha. Dr. Sohini Mahapatra, Ms. Rishika Khare, and Nikita Pattajoshi are associated with the project.

6. Project on Social Mapping/Household Survey of Migrant Workers in Odisha (Phase III)

7. Role of Ashram Schools in Protecting the Human Rights of Students in Odisha: An Empirical Study by Indian Council for Social Science Research (ICSSR)

In furtherance of this endeavour, the University has set up various Research Centres which have teachers and students as members. The centres are involved in the conduct of research and publication. In furtherance of the objective of conducting quality research, these centres have been engaged in conducting various workshops, conferences, seminars, webinars, moot court competitions, consultations with governmental agencies and guest lectures including the execution of Memorandums of Association with various governmental agencies, think tanks and data labs. It is worthwhile to note that these initiatives have resulted in the creation of a knowledge base which will not only enrich and enhance the existing knowledge base but will also lay the foundation for further research embedded in the idea of futuristic legal growth and development. National Law University Odisha can thus proudly boast of being one of the few law universities to have taken up the task of studying the impact assessment of laws through analysis of real-time data from the communities, stakeholders, and implementers of legal programs through various collaboration with national and international associations.

CENTRE FOR CHILD RIGHTS

Centre for Child Rights has been one of the most active centres at NLUO ever since the inception of the institution. With the continuous support from the Central and State Governments and UNICEF, the CCR has managed to enlighten the child rights lobbies with its research and ability to generate a movement. With the recent focus of the world on importance of children visible through the Sustainable Development Goals and India's focus on issues pertaining to *Baal Panchayats*, Child Friendly Villages, and overall rights of children the CCR becomes even more relevant and its need to conduct action oriented research coupled with action oriented goals become the need of the hour. It was with this emphasis that there was a felt need to institute the Chief Minister's Chair Professor at NLUO.

NLUO's first Chief Minister's Chair Professor, Prof Biraj Swain joined NLUO in January 2024. NLUO is the first institution in India to be granted the position of Chief Minister's Chair Professor, sanctioned by the Government of Odisha. This is the only fully functional chair professorship on child rights across all National Law Universities. It has an expansive vision with a five-member sanctioned staff strength.

The vision is speaking about the current living realities of the children and addressing the pressing challenges that are faced in the way of achieving meaningful childhoods and increasing life chances to be alive and thrive. The following objectives are intended to be achieved with the revamped and rejuvenated Centre for Child Rights:

- Legal literacy and building a rights-based temper
- Periodic studies/assessment of core laws/policies/legal provisions and flagship programmes translating the laws on ground (JJB, POCSO, CICL, CNCP, SCPCR, DCPU, VLCPC etc.)
- Capacity building on juvenile justice and child rights
- Collaboration with other NLUs, CCRs and other Universities
- Advocacy and collaborations with State and non-state actors w.r.t emergent reforms
- Research dissemination via conferences and public advocacy
- Collaboration with and building journalistic perspectives
- Provide leadership and accountability to deliver current projects
- Leadership and mentorship of the team and students
- Create credentialed flagship products / reports / processes and institutions in line with State of World's Children
- Serve as the resource centre of excellence to the HC-JJC Track and encourage Child Rights'
 Enabling environment
- UPR / UN CRC reporting: Official and shadow reporting
- Multi-media explainer series
- Media fellowships on child rights to increase reportage
- Media engagement to influence state of child rights' journalism
- Extensive knowledge management i.e. research dissemination & advocacy


Critical Perspectives Promoting Theoretical, Empirical and Policy Understandings between February 14 to 16, 2024 from 14th to 16th February 2024

1. Key publications which were conceptualised, created and launched at the ISCI, from the CCR:

Media Scan Research on Children in News Poster Panels: This is the first ever research done by any law school on media coverage of issues concerning children in India and the world. Three legacy news brands, the Indian Express, The Hindu and The Times of India have been analysed on their content and coverage of children in news for the month of November 2023, using the lens of the UNICEF Press-Wise Media Manual and the guidelines issued in the A.K. Asthana vs Union of India judgement of 2012 (WP 787/2012). This research has been conceptualised by Prof Ved Kumari and Prof Biraj Swain. The faculty guides are Prof Biraj Swain and Durbadala Mantry and conducted by student-authors Anuj Kulhar, Avismrita Shyamali Rai, Ishaan Aryan and Suraj Mishra.

The Kaleidoscope of Children: Issues through the Lens of the Youth is a project born in the classroom. It makes students delve deep into the pictures of children, sense their life situations, draw upon the students' own vantage, their empathy and further construct the violations the photographed children are experiencing. In the next step, the students build on legal recourse to challenge those deprivations. It is about discovering the human being before tapping into the lawyer in the NLUO students and building on solidarity and fraternity, core principles enshrined in the Indian constitution.

MEMORANDUMS OF UNDERSTANDING IN FORCE AT NLUO

1. MOU with Vital Strategies

National Law University Odisha signed an MOU with Vital Strategies, New Delhi to undertake a policy intervention project on 'Global Tobacco Control' from January 2024 to June 2025. The MOU is an extension of the Project on Tobacco Control Initiatives that NLUO was undertaking in collaboration with The Union Against Tuberculosis and Lung Disease. As a part of the Project, NLUO has developed free resource material in English and Odia for public awareness of Tobacco Control laws. Trainings are being offered to para-legal volunteers and community youth volunteers on their role in undertaking tobacco control measures. Additional activities under the Project include offering capacity-building sessions, supporting governments in adopting stronger policies, and field research in Odisha.

2. MOU with V. V. Giri National Labour Institute

National Law University Odisha signed an MOU with V.V. Giri National Labour Institute (VVGNLI), Noida in order to facilitate academic exchange. Under the MOU both the institutions have agreed to extend cooperation in undertaking collaborative research projects, seminars, workshops, exchange of faculty, sharing of library resources etc. This collaboration will greatly enhance the already growing scholarship in labour law at NLUO.

3. MOU with AIC Nalanda, Bhubaneswar

National Law University Odisha has executed and MOU with AIC Nalanda, Bhubaneshwar with the intent of promoting entrepreneurship and knowledge dissemination in the field of Intellectual Property Rights. The MOU was executed on the World IP Day.



4. MOU with The Art of Living Foundation, Sri Sri University

National Law University Odisha signed an MOU with The Art of Living Foundation, a volunteer-based, humanitarian and educational non-governmental organization renowned

for its transformative programs. TAOL joins hands with NLUO to enhance the comprehensive development of our academic community. The Memorandum of Understanding (MOU) was signed by the Registrar, Prof. Rangin Tripathy and the faculty advisors of Health and Wellness Committee, Dr. Arjyalopa Mishra and Ms. Sonal Singh. This MOU highlights two impactful programs: firstly, the Youth Empowerment & Skills Program (YES! +), a four-day workshop focusing on stress management, interpersonal skills, concentration enhancement and second is a Faculty Development Program (FDP), a three-day intensive training designed to equip faculty and staff with essential mind management techniques, leadership skills, and overall well-being strategies.



5. MOU with Start-up Odisha, Government of Odisha

National Law University Odisha signed an MOU with Start-up Odisha, Government of Odisha. The exchange of MOU happened in the thematic session of the Start Up Odisha in the presence of Shri Pratap Keshari Deb, MSME Minister, Shri Saswat Mishra, MSME Department Principal Secretary, Shri Omkar Rai, Executive Chairperson, Odisha Hub and other officials of the Ministry of Skill and Development, Government of Odisha and Prof Ved Kumari, Vice chancellor, NLUO, Prof Rangin Pallav Tripathi, Registrar, NLUO and faculties of NLUO. The main objective of the MOU is to provide all types of legal assistance to Start-up Odisha. The assistance would involve conducting seminars, workshops, start-up weekends, training programmes in collaboration with Start-up Odisha. It would also include collaborative research, teaching, and dissemination of research findings and publications.



6. MOU with Odisha Police, Government of Odisha

Odisha Police entered into a memorandum of understanding with National Law University Odisha, Cuttack to establish a Police-Academia Interaction Forum (PAIF). The forum would focus on facilitating a mutually beneficial interaction among the police officials, academicians and students. The students of NLUO can participate in internships with the Crime Branch of Odisha Police and other wings of Police Department. Additionally, Police officers can also attend training courses at NLUO. It would provide the students practical exposure to workings of police and real life exposure to investigation and law enforcement through academic interactions and internships in various departments of the state police such as the Crime Branch, Crime Investigation Department (CID-CB), Economic Offence Wing (EOW), State Forensic Laboratory (SFSL), Prisons and others.



7. MOU with PLR Chambers

National Law University Odisha signed an MOU with PLR Chambers. The main purpose and object is to collaborate on matters relating to legal advisory, legislative drafting, exploratory research, empirical studies, modelling, business advisory, project consultancy,

regulatory and policy issues to support public and private sector funding agencies in transitioning from concepts to commercially viable frameworks.



8. MOU with The Centre for Adivasi Research and Development, Odisha

A Memorandum of Understanding (MOU) was signed between National Law University Odisha and The Centre for Adivasi Research and Development (referred to as CARD), Odisha. CARD will work along with the Centre of Tribal Rights which has been established at National Law University Odisha to conduct both qualitative and quantitative, action-oriented and policy research on issues related to tribal welfare. The objectives of MoU are to identify and study social, cultural, economic, political, demographic, ecological and environmental related problems, needs of the people and emerging tribal community issues from an interdisciplinary perspective.

9. MOU with The Piringa Faculty of Law, University of Waikato, New Zealand

National Law University Odisha signed a Memorandum of Understanding with The Piringa Faculty of Law, University of Waikato, New Zealand. The primary objective of the MoU is to further academic scholarship and research through collaborative arrangements. In furtherance of the same, both institutions shall, inter alia, develop collaborative teaching and research programmes, and exchange academic resources and research findings and publications. The MoU shall be in effect for five years.

10. MOU with Directorate of Prison and Correctional Services, Government of Odisha

National Law University Odisha signed an MoU with the Directorate of Prisons and Correctional Services, Odisha. The MoU was signed by Registrar, Prof. Yogesh Pratap Singhand DIG, Prisons Mr. Subhukant Mishra in presence of Hon'ble Chief Justice Dr. S.

Muralidhar, Vice-Chancellor Prof. Ved Kumari, and DG Prison, Mr. Santosh Upadhyay. Under this Arrangement, the University and Prison Dept. will jointly perform various research activities and training programmes.

11. MOU with Cyber Law University

National Law University Odisha signed an MOU with the CyberLaw University. Cyber Law University is an online education platform dedicated exclusively to Cyberlaw and related disciplines. It aims to disseminate knowledge regarding the constantly evolving trends impacting cyberspace and connected paradigms.

12. MOU with Sri Sri University

National Law University Odisha signed an MOU with Sri Sri University. The prime goal of this MOU is to foster collaboration, provide opportunities for developing strength in various projects and academic areas and facilitate the advancement of knowledge around mutual concern based on reciprocity, best effort, mutual benefit, and frequent interactions and engagement of both the Universities.

13. MOU with CivicDataLab

Centre for Law, Public Policy and Good Governance facilitated the signing of an MOU between National Law University Odisha and CivicDataLab to facilitate data-based research at the University. As a part of this partnership, the Centre will be supporting CivicDataLab in offering tech literacy and capacity-building opportunities to the faculty and students at National Law University Odisha, and in reciprocation, the University aims to extend its expertise in legal research and data analysis.

14. MOU with Commonwealth Human Rights Initiative

National Law University Odisha signed an MOU with Commonwealth Human Rights Initiative, New Delhi on February 1 2022 to establish a framework for institutional collaboration and cooperation between the participating institutions to promote academic learning, training, research, fieldwork, workshops and further explore the possibilities of students' engagement in internship programmes.

15. MOU with NISWASS Bhubaneswar

National Law University Odisha signed an MOU with the National Institute of Social Work and Social Sciences, Bhubaneswar. The MOU aims at collaborative research and study for the B.A. Specialisation programme offered by National Law University Odisha. NISWASS will support the students of National Law University Odisha by providing internships and offering clinical subjects in the field of Advocacy and skill-based courses.

16. MOU with Public Health Foundation of India

National Law University Odisha has executed an MOU with the Public Health Foundation of India with the aim of strengthening legal research in areas of public health specifically in the aftermath of destruction caused by COVID-19 Pandemic.

17. MOU with World Vision India

National Law University Odisha, executed an MOU with World Vision India in order to improve accessibility of empirical research tool to NLUO students aiding them in conducting field studies in social sciences research in the most scientific manner as possible.

18. MOU with Insolvency and Bankruptcy Board of India

A Memorandum of Association has been executed between National Law University, Odisha and Insolvency and Bankruptcy Board of India. The MOU primarily seeks to achieve the cooperation between the two organisations in regard to the insolvency and bankruptcy related activities.

PUBLICATIONS BY NATIONAL LAW UNIVERSITY ODISHA

1. NLUO Law Journal

The NLUO Law Journal (ISSN 2348-8913) is the flagship publication of National Law University Odisha. The annual peer-reviewed journal aims to encourage legal scholarship in national and international interdisciplinary legal issues. The journal publishes and curates frontier research in multiple fields under the broad umbrella of contemporary issues in the legal field.

2. Human Rights Law Journal

Human Rights Law Journal (HRLJ) is an annual double-blind, peer reviewed academic journal bearing ISSN No. 2581-3307 brought out by National Law University Odisha with an objective of encouraging legal writing and scholarship in the field of human rights. The Journal started in the year 2016 and has received quality submission, both doctrinal and empirical in nature from members of the legal academia, professionals and students.

3. Journal on the Rights of the Child

Journal of the Rights of Child was first launched in 2016 under the auspicies of Centre for Child Rights, NLUO. The Centre was established with the support of UNICEF in the year 2015 with a mission to improve access to justice for children and promote research, advanced learning and advocacy to strengthen child rights laws, policies and practices in India. The journal has since been the voice of the Centre.

4. NLUO Student Law Journal

The NLUO Student Law Journal (NLUO-SLJ) is an initiative by the National Law University Odisha to provide a forum for students to voice their concerns, questions, scepticisms and opinion. International Conference

The 9th Conference of the International Society for Child Indicators: Global Childhoods: Critical Perspectives Promoting Theoretical, Empirical and Policy Understandings between February 14 to 16, 2024. Participants from nearly 25 countries participated in the conference making it one of the most attended conferences. Webinar on Trademark Licensing and Registration: Emerging Trends



IDIA

National Law University Odisha is recognized as one of the chapters of the IDIA (Increasing Diversity by Increasing Access to Legal Education) Program helping students in the preparation for the CLAT exam. National Law University Odisha chapter of IDIA also helps visually challenged and other students in need of support. The Moot Society, NLUO

The Moot Society (TMS) of National Law University Odisha is a student-run body managed under the guidance of a faculty advisor administering all the mooting-related activities at the University. The Legal Aid Society, NLUO

The Legal Aid Society ("LAS") at National Law University Odisha is one of the most active and vibrant Legal Aid Societies of the country. LAS is also one of the very few legal Aid societies in the country which has a holistic aim of not only providing Legal Aid and Legal Awareness but also undertaking humanitarian causes and relief.

COMMUNITY OUTREACH PROGRAM OF NATIONAL LAW UNIVERSITY ODISHA

Project Kutumb

The project is the flagship project of National Law University Odisha. Prof. Ved Kumari directly overviews the progress of the project working in close coordination with Prof. Biraj Swain, CM Chair Professor, Centre for Child Rights.

Background:

India is a signatory to the United Nations 2030 Agenda for achieving Sustainable Development through 17 identified Goals. In order to achieve these goals, the Government of India is making strategic efforts towards inclusive development through "Whole of Government and Whole of Society" approach. As part of this approach, the Ministry of Panchayati Raj, while emphasising on the role of villages and panchayats in bringing about progressive changes at the grassroots has divided the Sustainable Development Goals (SDGs) into various themes. Of these, Theme 3 focuses on the creation of Child Friendly Villages which aims at the accomplishment of 8 SDGs as depicted below:



With the objective of contributing to the national commitment towards creation of Child Friendly Villages, NLUO had declared 2023 as the "NLUO Year of the Child". To give effect to this declaration NLUO also adopted three villages in the district of Cuttack, namely *Brajabeharipur*, *Balmikinagar* (Mundasahi) and Babatilakanagar. The objective is to make necessary interventions in these villages to accomplish the relevant SDGs.

Way Forward

Since these goals and objectives essentially revolved around right of children. The Centre for Child Rights, National Law University Odisha was made the nodal agency for coordinating all activities pertaining to Kutumb Project. Thus with the approval from the then Chief Minister Mr. Naveen Patnaik, NLUO constituted a Chair Professorship for Centre for Child Rights. Ms.

Biraj Swain was appointed as the CM's Chair Professor and she joined the institution in January 2024. After her arrival a full team with Ms. Swagata and Mr. Amulya was constituted to partake in the activities of the Centre and also assist the office Vice Chancellor with the upcoming 9th Conference of the International Society for Child Indicators: Global Childhoods: Critical Perspectives Promoting Theoretical, Empirical and Policy Understandings. Prof Swain and her team have ever since been painstakingly working on various activities towards achieving the said goals.

Journey so far

It is this prudent to note that various activities have been undertaken so far as discussed below:

- 1. Talent Hunt show for members of community from Braja Beharipur, Munda Sahi and Baba Tilka Nagar was conducted on October 8, 2023 by NLUO under the aegis of Project Kutumb.
- 2. A Financial Literacy Program was organised by NLUO's Project Kutumb in coordination with Centre for Child Rights was conducted on April 4, 2024 for the members of the adopted communities.
- 3. In addition, the members of the communities were encouraged to participate in the cultural events that were organised as part of the annual flower show.
- 4. Vulnerability mapping within the communities has taken place allowing for further research on the subject.
- 5. Stress-testing of tools for data collection within these communities has also taken place.
- 6. A learning and sharing session at the 9th Conference of the International Society for Child Indicators: Global Childhoods: Critical Perspectives Promoting Theoretical, Empirical and Policy Understandings held on February 14, 2024 was conducted wherein the success story about Kutumb was shared with the delegates and participants of the conference.



These events have helped build a rapport with the community which helped conducting the social mapping and vulnerability mapping of these communities. A ground level intervention programme has been developed and weekly activities under the plan have been initiated to achieve the larger goals of generating awareness about sports, mediation, welfare schemes, cultural activities tribal rights etc., and consequently carry out need based interventions.

National Law University Odisha's library is without doubt the University's pride and joy. In the duration of last twelve years, it has achieved highest standards which are commendable for teaching and basic research purposes. It houses a collection of **15679** books, about **3584** primary legal texts (such as copies of bare acts, law commission reports, etc.), and more than a hundred law reports, academic journals, and the like amounting to a total of **8754** individual volumes. Particular interest to law scholars is the acquisition of complete sets of older law reports such as the Law Reports (Indian Appeals), Moore's Indian Appeals, the Criminal Law Journal, and Calcutta Weekly Notes. Columbia Law Review, Stanford Law Review and Contemporary Problems, Lyold's Law Reports, etc. Unlike contemporary reports these are not readily available online, which make hard copies essential and irreplaceable.

Consequently, this collection acquired by National Law University Odisha is of inestimable value to researchers investigating legal developments of the last few centuries. The National Law University Odisha library has 14 Databases including, SCC online, Manupatra, Hein Online, Westlaw India, JSTOR, Kluwer Arbitration, Kluwer Competition Law, Oxford Competition Law, Oxford Constitutions of the World, Oxford Legal Research Library, Oxford Reports on International Law etc., 10 individual e-journals i.e. Asian Journal of International Law, Air and Space Law, Economic Political Weekly, ICSID Review, Journal of International Economic Law, Journal of International Trade Law and Policy, Journal of World Trade, South Asian Studies, Indian Law Review along with EBC Reader, Cambridge, EBSCO, Hart and Oxford e-books. These e-resources are also accessible by the faculty members and students outside the university campus either through VPN/Sophos or through remote login through the INFED authenticated system provided by INFLIBNET. National Law University Odisha library is also a member of DELNET which allows our students and faculty access to a wide variety of literary resources. Apart from this, National Law University Odisha library has a subscription to an anti-plagiarism software, turnitin for all its users along with free access to another anti-plagiarism Original through INFLIBNET exclusively for faculty members and research scholars
